I also understand and appreciate that controlling that risk is a responsibility that as a participant, I must share. BY MY PARTICIPATION, I AM ACKNOWLEDGING THAT THE RISKS OF INJURY ARE ACCEPTABLE TO ME. Further, if I am injured, become ill, or suffer any other personal loss while participating in this activity, I and my family hold harmless the RED RIVER REGIONAL MARKSMANSHIP CENTER (RRRMC) and the RRRMC board of directors for conduct of the activity and the rendering of services to me in association with my participation, excepting occurrences resulting from gross negligence and wanton misconduct to the fullest extent permitted by law.
